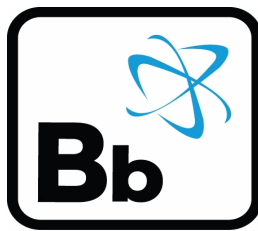
ORELAP accredited cannabinoid analytes include only CBDA, CBD, THCA, delta-9-THC, and delta-8-THC.

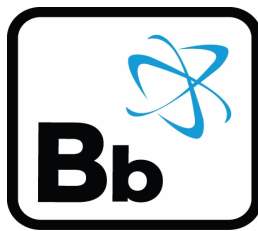
