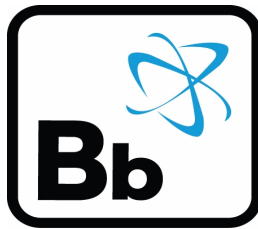

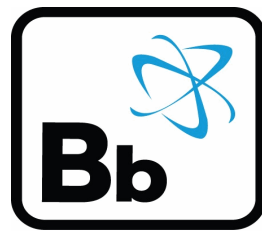

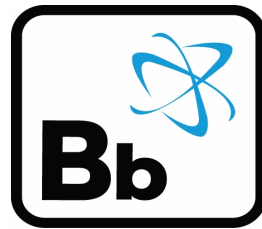

 - L Duplicate sample relative percent difference (RPD) exceeds QC limits.
