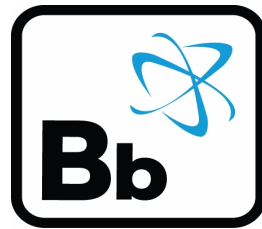

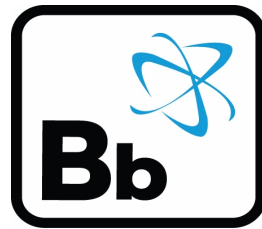

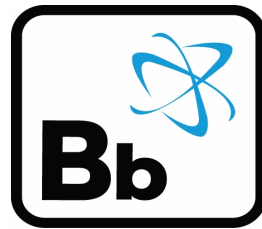

 - C Interference due to co-elution.

 - H Non-homogenous sample matrix affecting RPD and/or QC.
 - I Manual Integration was performed.
 - L Duplicate sample relative percent difference (RPD) exceeds QC limits.
 - M Anomalous results due to matrix interference
 - P Peaks manually split.
 - Q1 QC out of limits but still OK
